Parcel contains 4.3 acres±.

"EXHIBIT B"

Permitted Uses: The outdoor aquatic entertainment venue and facility that will include multi-tiered pools, a video board, a substantially reduced stage for small music events, and customary accessory uses such as bars, restrooms, souvenir shop, etc. The subject property will now be governed by the regulations pertaining to E-3 overlays as specified in the Land Use Chapter of the City of Osage Beach Municipal Code the submitted site development plan, and the following.

This facility will operate with the same time restraints and hours of operation as outlined in the code governing the E-3 overlays.

Construction Requirements: All construction will be in conformance with the codes that are adopted by the city at the time that a Building Permit is requested for any portion of the development that a permit is required.

Parking: Will be required to meet the City Code governing off street parking for such a use. The appropriate number will be reached using land-based parking lot spaces only. If a need for additional parking becomes evident, additional parking facilities will be required to be constructed on the commercially zoned property on site and owned by the applicant.

There will be no parking allowed along the roadways of Beach Drive or Sunset Drive. Any vehicles found parked in these locations will be subject to tow.

Facility access, ingress, and egress: Beach Drive must be rebuilt into a collector status street as determined by the City's contract engineer. The road will be reconstructed past the entrance into the Backwater Jacks complex. The owners will be required to work with the City and their contract engineers to finalize plans and construction procedures for the completion of the project. Funding for the design and construction of Beach Drive will be provided by the applicant. The reconstruction of Beach Drive must be complete by March 1, 2023. Failure to do so could result in the revocation of the E-3 overlay by the Board of Aldermen.

The Sunset Drive entrance into the complex will be gated and marked as a "private entrance, not for use as public access". The Sunset Drive entrance will only be used by the people renting the Backwater Jacks vacation rentals, employees, and in case of emergency. Emergency usage will be in response to notification or request by the Osage Beach Police Department. All commercial traffic will be removed from Sunset Drive in accordance with the approval of this request.

Signage: Signage located at the Sunset Drive entrance will be a monument style sign that will meet the requirements of a Residential Subdivision. Any signage on the Sunset Drive access location will be for the Backwater Jacks vacation rentals only. This sign cannot be back lit or have a digital reader board or running display. Other interior signage is required to meet the regulations established by the City's Sign Code for commercial properties. The applicant will be required to get a sign permit for any new signage.

Sound Control Requirements:

Unless otherwise defined herein, all terminology shall be in conformance with applicable

publications of the American National Standards Institute, Incorporated (ANSI) or its successor body.

Instrumentation used in making sound level measurements shall meet the following requirements as specified in Section <u>220.040</u> of Chapter <u>220</u>.

Department Comments and Recommendation:

As requested by several aldermen at the March 4, 2022 Board of Aldermen Meeting, I am proposing an amendment to the Osage Beach Municipal code which currently establishes the minimum building permit fees of \$40.00 for residential permits and \$120.00 for commercial permits. This proposed amendment provides an exception to the building permit fees for the replacement of water heaters and heating, ventilation, and air conditioning (hvac) systems, whereby the fee for such permits is set at \$0.00. Included in the amendment is my recommendation that any fees previously collected, in 2021 or 2022, for water heater or hvac replacement permits (6+), be rebated.

Additionally, this ordinance has been structured such that the building department will have 12 months to collect permitting and inspection data related to water heater and hvac replacements. That data will be reported back to the Board of Aldermen at the first meeting in May of 2023.

The Building Department recommends approval.

BILL 22-11 ORDINANCE 22.11

AN ORDINANCE OF THE CITY OF OSAGE BEACH, MISSOURI, AMENDING THE OSAGE BEACH CODE OF ORDINANCES BY CREATING A NEW SECTION 109.1 (D) WITHIN SECTION 500.020, ELIMINATING THE INSPECTION FEE FOR REPAIR OR REPLACEMENT OF WATER HEATERS AND HVAC SYSTEMS, REBATING ANY FEES PREVIOUSLY PAID THEREFORE AND REQUIRING A REPORT TO THE BOARD OF ALDERMEN ABOUT THE TIME SPENT ON COURTESY INSPECTIONS FOR THESE SYSTEMS WITHIN THE YEAR.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF OSAGE BEACH, AS FOLLOWS:

Section 1. Chapter 500, Article I SECTION 500.010: 2018 International Building Code - Adoption is hereby amended by enacting a new Section 109.1 (d) [new material set out below in **BOLD PRINT**] to read as follows:

C. Plan Review Fees: When the total valuation of a proposed building exceeds one hundred thousand dollars (\$100,000), and a plan is required to be submitted, a plan checking fee shall be paid to the City of Osage Beach at the time of submitting plans and specifications for checking. Such plan checking fee shall be one-half of the building permit fee set out above and shall be a credit toward the total building permit fee when the building permit is issued.

D. Exception. The building permit fee for replacement of water heaters and heating ventilation and air conditioning (HVAC) systems otherwise imposed under Section 500.020 Section 109.1 (a) and (b) above shall be set to \$0.00. For every permit issued for the repair or replacement of water heaters and heating ventilation and air conditioning (HVAC) systems the Building Department shall provide, at no cost, a courtesy inspection of the water heater or HVAC system.

Section 2. Reporting. The building department shall compile a report of the total number of inspections performed for any repair or replacement of a water heater or HVAC system and the approximate time involved and submit that report to the Board of Aldermen at its first meeting in May 2023. Any such fees for inspection of any repair or replacement of a water heater or HVAC system previously collected in 2021 or 2022 shall be rebated.

Section 3. Severability.

The chapter, sections, paragraphs, sentences, clauses and phrases of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional or otherwise invalid by the valid judgement or decree of any Court of any competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this ordinance since the same would have been enacted by the Board of Aldermen without the incorporation in this ordinance of any such unconstitutional or invalid phrase, clause, sentence, paragraph or section.

Section 4. Repeal of ordinances not to affect liabilities, etc.

Whenever any part of this ordinance shall be repealed or modified, either expressly or by implication, by a subsequent ordinance, that part of the ordinance thus repealed or modified shall continue in force until the subsequent ordinance repealing or modifying the ordinance shall go into effect unless therein otherwise expressly provided; but no suit, prosecution, proceeding, right, fine or penalty instituted, created, given, secured or accrued under this ordinance previous to its repeal shall not be affected, released or discharged but may be prosecuted,

enjoined and recovered as fully as if this ordinance or provisions had continued in force, unless it shall be therein otherwise expressly provided.

Section 5. The Mayor of the City of Osage Beach is hereby authorized to take all actions which may be necessary to fully enact this Ordinance.

<u>Section 6.</u> That this Ordinance shall be in immediate force and effect upon it passage by the Board of Aldermen and approval of the Mayor.

Department Comments and Recommendation:

This project was bid in February and the bid opening took place on February 28th. The City received 4 bids for the Autumn Lane Improvements Project. The bid tab and the Stockman Construction's bid information is attached. Stockman Construction is the low bidder with a bid amount of \$192,999.00. The City has worked with Stockman Construction multiple times in the past with good results. Most recently they completed the Mace Road Phase 2B project for the City. The budget for this project is \$155,500. This is a project that is being funded by the Osage Beach Special Road District. The

Special Road District has made it clear that the City will need to cover the difference between funds that the Special Road District has committed to this project (154,393.25) and the low bid mentioned above.

Project Budget = \$155,500 Stockman Constructions Bid = \$192,999 Difference = \$37,499

I spoke with Dave Van Leer about the bids for this project. He states that the bids are higher than the budget due to the rising cost of construction materials. Cochran Engineering and City Staff do not believe that rebidding this project would result in the City getting bids lower than what we have here.

A budget amendment will follow this agenda item.

I recommend approval.

City Administrator Comments:

Autumn Lane Improvement Project timeline of events:

- April 2019 Osage Beach Special Road District (OBSRD) commissioners approved a financial commitment of up to \$51,000 based on the project estimates at that time.
- **September 2019** The Board of Aldermen approved City staff to work on the project, providing preliminary and construction engineering for the project,
- 2020 ROW determinations, property owner contacts, and other legal work took place in 2020, but otherwise work on the project was slow throughout the year; this was mainly due to changes in City staff and various effects of the pandemic,
- May 2021 Cochran Engineers presented project details the the Board of Aldermen; the Board of Aldermen recommended scope changes to the project to include the design of the project meet City design guidelines, extending the project to the City limits, as well as ensuring the necessary steps were to be taken to bring the road into City inventory upon completion,
- August 2021 Cochran Engineers presented to the Board of Aldermen the revised project scope based on the direction received in May and the updated project estimate, \$154,393.25,
- **September 2021** OBSRD committed additional funds based on the updated scope and estimate for a total financial commitment of \$154,393.25
- **February 2021** The project was bid, resulting in a favorable low bid of \$192,999; cost increases over the engineer's estimate are contributed to current market factors; the OBSRD was presented with the bid details at their February meeting along with a request to consider additional funding,

March 2021 - At the March 3, 2022 Board of Aldermen meeting, OBSRD
Commissioner Ron Schmitt stated to the Board that the OBSRD was
appreciative of the joint effort on this project; also stating per their meeting in
February, the district would not be committing additional funding but encouraged
the City to move forward with the project.

Based on the FY2022 Operating Budget, y/e estimated unrestricted monies in the Transportation Fund could cover the additional cost to the City, should the contract be awarded. A budget amendment bill follows this request, outlining a budget amendment of \$37,500.

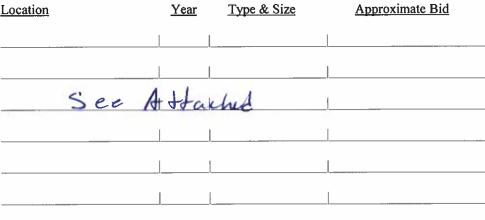
